

# Terms of Use – L-Parking Application

**Last Updated:** August 27, 2025

*This English version of the Terms of Service is provided solely for the convenience of users. In the event of any discrepancies or inconsistencies between the Polish version and this English translation, the Polish version shall prevail and be legally binding.*

## 1. General Provisions

1. These Terms of Use define the rules for using the L-Parking mobile application, available on Android and iOS devices.
2. The owner of the application is Dariusz Curyło.
3. The application allows users to share private parking spaces and reserve available ones using a ParkCoin-based system.
4. Using the application implies acceptance of these Terms of Use.

## 2. Definitions

**Application** – the L-Parking mobile app enabling the sharing and reservation of parking spaces.

**User** – a person with an active account in the application.

**Account** – an individual user profile in the application.

**ParkCoin** – a virtual currency used to make parking space reservations and earned by sharing your own parking spaces.

**Location** – a physical place (building address) where parking spaces shared via the app are located.

**Parking Space** – a physical parking spot available for reservation in the application, located at a specific location.

**Location Code** – a verification code required for access to some locations.

## 3. Rules of Using the Application

1. A mobile device with internet access is required for proper use of the application.
2. The following actions are prohibited:
  - using the application for unlawful purposes,
  - bypassing the application's security measures,
  - providing false information,
  - abusing the reservation system.
3. The application is intended for users aged 16 and above.

## 4. Registration and User Account

1. Registration is completed by providing an email address and confirming the account.
2. The user is responsible for the security of their account.

3. Users are responsible for keeping their login credentials confidential and must not share them with third parties. In case of suspected unauthorized access to the account, the user should immediately contact the application administrator. Wersja polska
4. The user has the right to delete their account. To do so, they must go to the "User Data" section and click the "Delete Account" button. The deletion request will be processed within 30 days unless it is canceled by the user during that period.
5. Account deletion is not possible if the user has a negative ParkCoin balance. In this case, the account can only be deleted after the balance has been settled.

## 5. Rights and Responsibilities of the User and App Owner

1. Users have the right to use the application features in accordance with its intended purpose.
2. Users are obligated to:
  - provide truthful information,
  - avoid posting illegal or offensive content,
  - follow these Terms of Use,
  - share only parking spots that they are authorized to use,
  - share their own parking spot only when it is actually unoccupied (e.g., their vehicle is not parked there at the time).
3. It is strictly prohibited to:
  - impersonate the owner of a parking spot (e.g., by adding a location the user has no rights to); such behavior will result in permanent account suspension,
  - make their own parking spot available in the app while it is actually occupied; this may lead to ParkCoin deductions, and in case of repeated violations – account suspension.
4. The app owner reserves the right to:
  - suspend accounts in case of a breach of the rules,
  - verify users regarding parking space sharing and reservations.
5. In the event of a violation of the Terms of Service, the app owner may impose additional sanctions such as: temporary account suspension, restriction of access to certain app features, ParkCoin deductions or a reset of the ParkCoin balance.
6. Users are required to respect common property and comply with the rules applicable at each location, including regulations set by housing associations or property administrators. It is prohibited to litter, block driveways, or engage in any behavior that hinders other users from accessing parking spaces.

## 6. Payments and Fees

1. The app operates using a ParkCoin system – ParkCoins are earned by sharing spaces and spent on reservations.
2. ParkCoins can also be purchased with real money via the Google Play platform. The current price list is available in the app.
3. Purchased ParkCoins are non-refundable.
4. ParkCoins have no monetary value outside the application and cannot be exchanged for cash.
5. If a reservation is cancelled less than 12 hours before it starts, only ParkCoins for the time after those 12 hours will be refunded.
6. When changing the location associated with the account, all accumulated ParkCoins will be reset. By making this change, the user agrees to forfeit previously earned ParkCoins.
7. The app owner reserves the right to modify the rules for earning and using ParkCoins, as well as other app functionalities. All users will be notified of such changes via the app or by email.

## 7. Reporting Issues with Reservations

1. If a reserved parking spot is unavailable at the scheduled time (e.g., occupied by another vehicle or otherwise inaccessible), the user has the right to report the issue via [Contact](#). Wersja polska
2. Each report will be reviewed individually by the administrator. If the report is confirmed, the ParkCoins used for the reservation will be refunded to the user.
3. Before submitting a report, the user is encouraged to contact the owner of the parking space. Contact details are available in the reservation details.

## 8. Personal Data Protection and Privacy

1. Details regarding personal data are available in the Privacy Policy.
2. The app collects data such as email, phone number, location information, parking space details, and reservation history.
3. Users have the right to access, edit, and delete their personal data.

## 9. Copyright and Intellectual Property

1. All rights to the application and its content belong to the owner.
2. Copying or modifying the application without the owner's consent is prohibited.

## 10. Liability and Limitation of Liability

1. The owner is not liable for user actions or errors resulting from incorrect app usage.
2. Access to the app may be temporarily limited for technical or maintenance reasons.
3. Temporary unavailability of the app due to maintenance, updates, or technical failures does not constitute grounds for any claims against the app owner.

## 11. Complaints and Dispute Resolution

1. Complaints can be submitted via email available at [Contact](#).
2. Disputes will be resolved by the court competent for the owner's registered address.

## 12. Changes to the Terms

1. The owner reserves the right to modify these Terms of Use.
2. Users will be informed of any changes via the app or email.
